Many of us are doing significant work on this issue and we need to provide a platform for visibility to share our work on climate change mitigation and adaptation with the public. I strongly believe that we are the profession best suited to solve the complex issues around climate change in the built environment and we will advance our profession by promoting this work. Not only can we educate each other and the public but sharing our solutions can serve as a catalyst to push the boundaries of our profession in this field.



With this in mind our chapter has launched the #ResilientLand Challenge. This is a direct call to action and we are encouraging every member to create social media posts related to your work on climate change issues using the hashtags #ResilientLand and #ASLASD. Posts can be made on Facebook, Instagram and Twitter – just be sure to use our hashtag #ResilientLand. The #ResilientLand challenge will run through March 31st and will culminate at the Landscape Architecture Month Kickoff event in April. This is when we will announce the most compelling post that addresses climate change specific to our region and that person or company will be awarded the 2019 Stewardship Award. They will also be published in a prominent local article and on the chapter website to promote their work on regional climate change.

CCASLA Legislative Update:

Legislative Session Ends, New Leadership in Sacramento, Grassroots Advocacy

The four California ASLA Chapters that make up the California Council of the American Society of Landscape Architects (CCASLA) have been busy representing you in Sacramento each Legislative Session.

Rich Risner, PLA, ASLA, Grounded Landscape Architecture, has been tracking this as the CCASLA President and State Director, and I serve as the Vice-President. This is my first year and first term, so I'm ramping up on a steep learning curve, but so far I've been glad to learn that an excellent group of well-informed lobbyists and landscape architects are working hard in Sacramento and across the state on all of our behalf.

LEGISLATIVE SESSION ENDS

In the final days of the legislative session, Governor Brown signed the Carrillo Bill (AB 2371) that names landscape architects as key stakeholders for the next state Model Water Efficient Landscape Ordinance (MWELo) update. Your CCASLA lobbyist made sure landscape architects were included in this legislation by educating the author of the bill regarding the value of your expertise when developing new water conservation policies. CCASLA will follow up by contacting the DWR staff to ensure landscape architects are part of the stakeholder committee formed to guide future changes in the MWELo.

Take a look at the various bills that we have been tracking in 2017 and 2018 in the Bill Tracking Report posted on www.cc-asla.org and let us know if you hear of any policies that can be updated to include landscape architects.

NEW LEADERSHIP IN SACRAMENTO

Democrats have gained a veto-proof supermajority in the California legislature, and Governor-Elect Newsom and the Assembly and Senate leadership will likely have some different priorities and emphasis than prior leadership. It will be important for us to get acquainted with our new leadership and inform them about the value of our profession to the state, as well as stay close to senior leadership to continue to reinforce our message. The new legislature was sworn in on December 3rd and Governor Newsom will be sworn into office on January 7, 2019.

Lobbyists identify and monitor key legislation and review key bills with the CCASLA Board. Our lobbyist for over 20 years has been Terri Thomas who retired at the end of 2018. She will be missed, but we were introduced to the firm of Edelstein Gilbert Robson

& Smith, LLC (EGRS) in 2017, with whom Ms. Thomas has been collaborating for the past 2 years. Don Gilbert, Mike Robson and Jason Ikerd from the EGRS firm have been involved in our CCASLA meetings to foster a seamless transition and CCASLA has approved their proposal to represent us as our lobbyists.

Water conservation will continue to be a big issue in 2019. Many bills introduced often are amended as they go through the legislative committees so the CCASLA Board will be monitoring the bills as they go through both houses of the legislature. Specifically lobbyist Gilbert suggests that the environmental community could be a partner to us in presenting some initiatives that could benefit landscape architecture and our communities.

GRASSROOT ADVOCACY

Board President Risner has established a new standard for each of our chapters to schedule and document meetings with our legislators. This will be in the form of an Advocacy Report which is submitted to CCASLA. This will be very important as we start lobbying for support of continuing our licensing authority during the Licensure Sunset review. The Landscape Architect Technical Committee (LATC) Licensure Sunset Review Report is available on their website at www.latc.ca.gov/docs/publications/2018_sunset and will be presented to the Assembly and Senate Business and Professions Committee in March 2019.

We need your help to continue to stress the value of landscape architects with local, state and national elected officials and agencies that we deal with that often create regulations that complicate or impede our ability to help our clients. We were notified in mid-December that ASLA approved a National Advocacy Grant that will help all four Chapters schedule and meet with our state legislators to educate them regarding the wide-range of areas that landscape architects practice and the value they provide society in addressing climate change to establish plans to protect our communities during droughts, fire events and other natural disasters.

When you talk to our elected leaders and agency officials, let us know. Send us word of your advocacy efforts to CCASLA@sbcglobal.net and we will add it to our State CCASLA Advocacy Report to confirm we are letting elected officials know the value of landscape architecture in our communities and throughout the state.

ASLA San Diego Conference Host Committee Co-Chairs, Martin Flores and Vicki Estrada, then shared their vision for the Conference. 2019 Community Grant Recipient: Mercy Gardens Meditation Garden

The San Diego Chapter of The American Society of Landscape Architecture is happy to announce the winner of the 2019 Chapter Community Grant.



The grant is made possible through the ASLA charity golf tournament and our sponsors. Many thanks to those sponsors, coordinators, volunteers, and participants who contribute each year.

This year Mercy Housing California (MHC) 501c3, has been awarded our \$5,000.00 grant for their project titled "Mercy Gardens Meditation Garden." The grant is to be used at Mercy Gardens Development in Hillcrest towards landscape improvements including converting the front entrance into an area of drought resistant landscaping as well as modifying the backyard patio into a meditation garden with upgraded seating.

Our local member landscape architecture firm, Carson Douglas Landscape Architecture, provided the conceptual site design that includes new plantings, hardscape, site furnishings, entry signage, interpretive landscape plaques, including a plaque acknowledging the profession of landscape architecture and recognizing ASLA San Diego's contribution.

"They are a really deserving group of folks who live there and are almost in a forgotten corner of Hillcrest. The project will bring some much-needed curb appeal and a sense of welcoming at the entry. The heart of the design is out back where we have proposed a meditation garden" said Michael Brennon of Carson Douglas Landscape Architecture.

Eric Ligare, Resident Services Coordinator at Mercy Housing had this to say about Mercy Gardens:

"Mercy Gardens is a low-income residence for individuals with HIV. Since many of residents enjoy gardening and being outdoors, I felt this project would be a tremendous boost to their sense of pride in their community. I also had the residents input incorporated into the grant as a way to keep them occupied and remind them that they are valued and important since many of them struggle with low self-esteem and other mental health issues. Winning this was a tremendous boost to the morale of our building and many are excited for the new additions.

"We are also located across the street from Mercy Hospital in Hillcrest, and many of the doctors and staff have previously used our back-patio area as

Let me know if you have ideas or concerns as they relate to our profession or the organization, and I will discuss them with the San Diego Executive Committee and respond. Together we can have an impact!






- Climate resilience planning including sea level rise mitigation or adaptation




As your newly elected Vice President of Visibility and Public Affairs I would like to encourage your participation in our Communications Committee and highlight our Committee's Mission.


