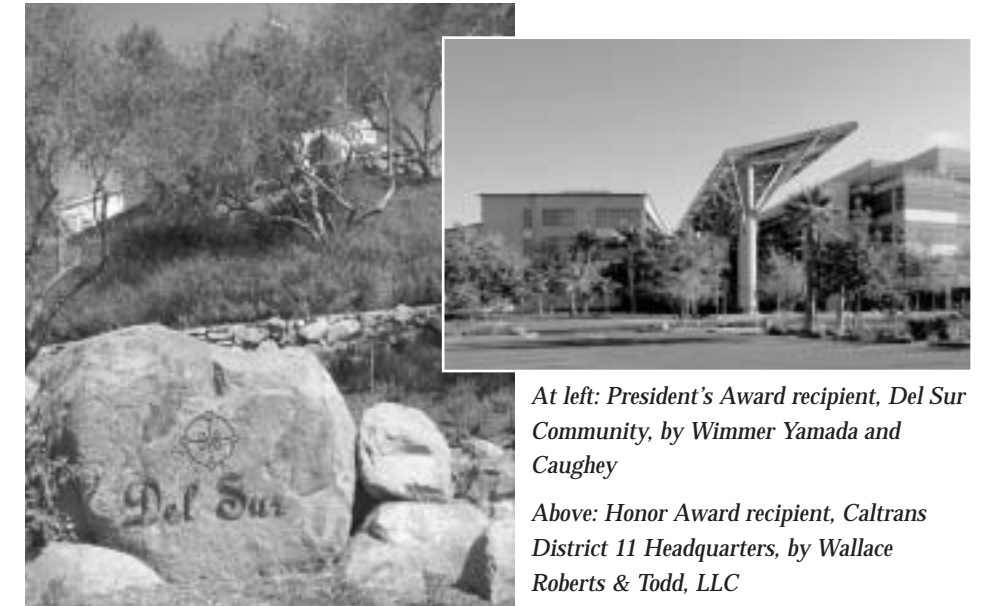
## 2008 Community Grant – Fallbrook Garden Club

## PRESIDENT'S MESSAGE

### Seeking Your Guidance to Serve the Profession and Lead the SD Chapter

Last fall, your San Diego Chapter of ASLA celebrated its 30th anniversary and all the accomplishments that have occurred over those years under the leadership of our Past Presidents.

As your incoming Chapter President, I'm bringing the 25+ years that I've been in public and private practice and as a former ASLA Chapter President (Northern CA Chapter) to the San Diego Chapter. I plan to assess the Chapter structure (committee activities and services) and address the need to promote landscape architecture as a vital profession.

Each President has lead the Chapter with their vision of what landscape architecture could or should be in San Diego. I'm seeking our members' input on what you envision the Chapter should/could do to directly benefit our membership and the profession.

- I'd like to focus on four areas in restructuring the Chapter. Those include:
- Providing services and practical educational opportunities to members.
  - Encouraging ASLA national to approve student chapters at 2 year colleges.
  - Educating members regarding their role in public policies (water, regulatory, etc).
  - Participating in public outreach and community education regarding the profession.

#### Member Services/Activities

I am beginning a reassessment of the activities and services that will provide value to you (job postings, programs that focus on nuts and bolts issues in the profession, emerging industry issues). I encourage you to let me know what you believe the Chapter should be doing to provide value-added services, programs

and networking opportunities.

#### Growing the Profession

Landscape Architecture has become one of the most expensive majors at many universities. This year, the San Diego Chapter successfully sought ASLA's recognition of student chapters at community colleges so we can encourage lower division students to move to accredited four-year/upper division landscape architecture programs. We must guide those who might choose landscape architecture as a profession and show them the importance and need for future viability of the profession.

#### Shaping Public Policy

We need to become more involved in shaping public policy both from an aesthetic and business sense and where it involves the health of the community. We'd like to work with local universities and municipalities to shape better decision-making to consider and shape examples of best practices to address many of today's critical issues.

#### Becoming a Public Resource

We need to work harder to educate the public regarding the importance of landscape architecture and share our successes to encourage future professionals to follow.

I would greatly appreciate your input to improve the delivery of Chapter educational opportunities and to develop the types of programs and education that meet your needs.

## ASLA National Trustee Report

Glen Schmidt, FASLA, Schmidt Design Group

ASLA's National Board of Trustees (BOT) meeting was held in San Francisco prior to the Annual meeting on October 4-5, 2007. Summary of business conducted included:

- Bi-law revisions were approved by the BOT to expand Student ASLA Chapters to include community colleges and other non-accredited programs.
- The BOT reviewed and approved the 2008 Annual Operating Plan.
- The BOT reviewed and approved the projected budgets for 2007, and 2008-2009.
- Program and Operations: Membership is up almost 5% since January of this year.
- Public Relations reported considerable growth in media inquiries and programs.
- Government Affairs: Advocacy networks have been monitoring legislation at both the state and federal levels.
- Board of Trustees voted to elect the 2007 honorary members.
- Progress on the Sustainable Sites Initiative program was presented.

**ASLA Water Conservation Committee:** Glen Schmidt and Marian Marum co-chair this committee which is reviewing the Model Landscape Water Conservation Ordinance.

**ASLA Stormwater Committee:** Glen Schmidt and Marian Marum co-chair this ASLA committee. The committee has met to review stormwater issues and legislations.

**Landscape Model Ordinance Committee:** Glen Schmidt co-chairs this city wide committee with Scott Molloy of the BIA. The committee has met more than a dozen times.

**City of San Diego Stormwater Advisory Committee:** Glen Schmidt is attending a Stakeholder's committee that is providing feedback to the City of San Diego regarding compliance with the Regional Water Quality Control Board (RWQCB) permit.

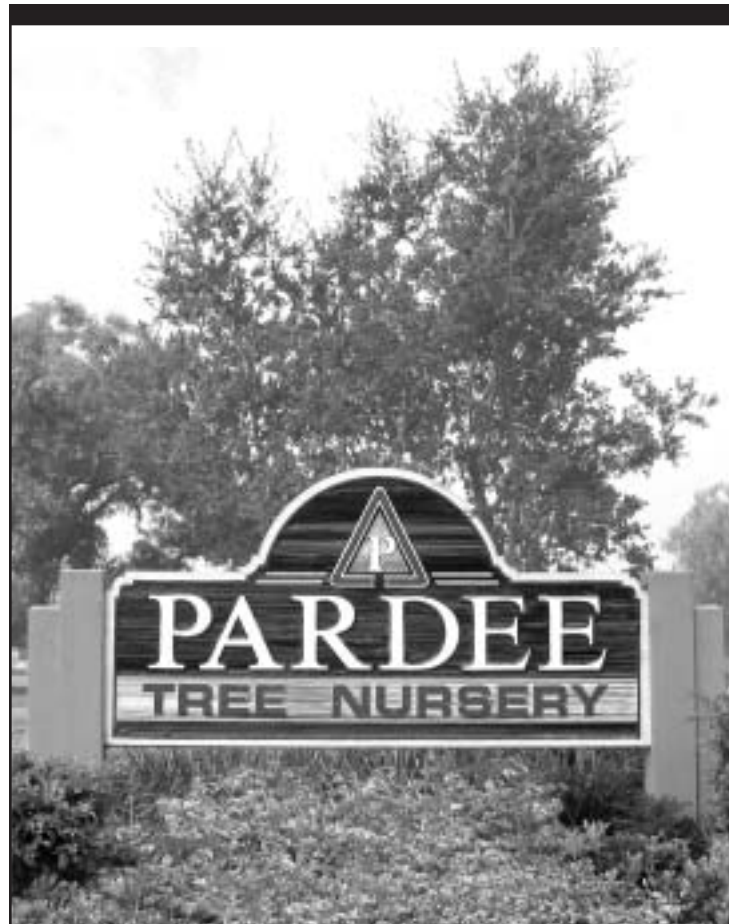
#### Legislative Update

Governor Schwarzenegger signed two important bills this past October. AB937 aligns the contract language for landscape architects with that of architects and also more completely and specifically defines the unlicensed practice of landscape architecture. The Governor also signed AB 1481, which creates a uniform, statewide permitting process for landscape irrigation uses of recycled water, such as parks, playgrounds and golf courses, by requiring the State Water Resources Control Board to adopt a statewide general water quality permit. This is another of many bills we were following during the legislative session.
